Participants registered online and joined the virtual presentations, which were generously provided by industry professionals and covered a variety of remediation topics including environmental forensics, soil remediation, and the Highway 104 twinning project in Nova Scotia.

### Introduction to the CLRA

The kickoff presentation, given by CLRA Atlantic's president, Abby van der Jagt, was an informal discussion about WHO the CLRA is, WHAT do we do, WHY do we exist, WHEN do we do things, and WHERE. It was geared toward new and prospective members and students.

### An Overview of Environmental Forensics

Presented by James MacDonald from AGAT Laboratories, this presentation touched on the sampling and analysis of petroleum hydrocarbon forensics and his role leading complex projects in the Maritimes.



## Presentation Summaries Continued

### Revegetating Difficult Soils

Renee Barrientos from ECBVerdyol presented several case studies detailing how using biotic soil amendments can increase vegetation success on sites when used as topsoil replacement or in conjunction with less than ideal soils.

### A Contractor's Perspective on Habitat Restoration for the Highway 104 Twinning Project

Jamie Burns Dexter Nova Alliance and Grace Gillies from The Municipal Group of Companies, presented an overview of the Highway 104 Twinning Project, a review of environmental permitting requirements, and various restoration works associated with the project including restoring fish habitat through culvert improvements, reclamation associated with stream realignments, and wetland compensation requirements and strategies.
